In 2017, Genny received the prestigious Franklin Delano Roosevelt Award for fetal and maternal health, recognizing her dedication and work with women and babies. She certainly deserves the award, having personally delivered over 300 babies. Prior to joining Southwest General, Genny started the Midwifery Group at the former Bedford Hospital and spent 10 years with the group before it closed.

Genny and her husband have been married for 27 years and have two children and one grandchild. Some of her passions outside of work include horseback riding, swimming, hiking and travel. Genny also enjoys playing piano and is a huge Cleveland Indians fan.

When asked if she ever thinks about retiring... Genny smiles and says...."I'll know when it's time, but not anytime soon." We are sure glad to hear that!

We are a volunteer-driven organization blessed with talented and dedicated individuals who give generously of their time to provide much needed care for so many women in the northeast Ohio area.

As I approach my fifth month with Womankind, I can honestly say it has been a true pleasure to be devoting my time and energy to an organization with such an important mission. These first months have flown by as I've worked toward learning as much as I can about the organization. We have an ambitious plan for 2018 to increase awareness about Womankind and its mission throughout northeast Ohio with an expanded marketing plan; updating technology including designing a more vibrant and interactive website, updating our phones and computers; and designing a three-year strategic plan to explore strategies for increasing the number of women we serve through our maternal and prenatal clinic.

The Womankind Board of Trustees has a robust group of members who are actively participating in all aspects of Womankind to increase awareness and success of the organization. Three new members have recently joined, as on page 5. Everyone brings an energy and expertise to the table and I am thrilled to have joined an organization with a board as active as ours.

One of Womankind's more unique fundraising activities is the Baby Bottle Campaign. In 2017, \$105,000 was raised with baby bottle funds alone! We are so fortunate to have the participation of over 50 area churches, schools and organizations that participate each year. The Baby Bottle Campaign provides a great visual reminder to the community that their donations provide funding for medical and social needs of the women and families we serve. Bottles returned are filled with a mix of change and dollar bills, while others contain a single check in support of the mission. Each and every bottle reflects the story of someone in this community who has chosen to assist Womankind with providing pregnancy testing, prenatal care, counseling, childbirth education classes, medical supplies and more.

We are blessed with generous donors who provide the much needed funding to purchase items such as an OB Doppler, blood pressure monitors, educational materials, medical supplies and more (see list on the right). Other individuals and groups donate baby items such as diapers, formula (Gerber Gentle Brand is preferred), and clothing for children up to 24 months. We are entirely dependent on donations of baby items. There is nothing as gratifying as witnessing a mom who is able to keep her baby warm because of receiving a donated winter coat or knowing that a child will not go hungry because baby formula was donated to help that child. There is a great deal of need in this community and Womankind's thoughtful donors are generously assisting with meeting some of that need.

I wish to thank Eileen Murray who served as Executive Director at Womankind for twenty-four years. I had the privilege of shadowing Eileen for a week in December as she shared her knowledge, experience, thoughts, anecdotes and so much more with me in that short time frame. While I realize I will never fill her shoes, I believe we share a similar passion for the mission of Womankind and the desire to continue the vision of Womankind's founders. I cannot thank Eileen enough for her gracious and open-hearted welcome to me and I appreciate her tremendous support and thoughtful effort in preparing me to assume this role.
